Jewish Family Services welcomes increased number of refugees: emphasizes education and collaboration



previous year.

With national media headlines focused on immigration and the growing number of Syrian refugees in the country, resettlement agencies and communities are being called on to help more refugees than in the past. Jewish Family Services of Washtenaw County (JFS) has agreed to resettle 300 refugees this coming fiscal year, beginning October 2016, which doubles the number of refugees (150) the organization resettled in the

This increased resettlement effort creates an exciting time as the organization and community collaborate to provide refugees with services to adapt and thrive in their new homes. This requires careful, thoughtful planning. JFS hired a new case worker, and hopes to use increased volunteer and internship assistance this year to meet these needs. JFS leadership is also considering how current services must change to meet higher demand, such as ensuring the JFS food pantry is stocked, and that adequate housing and transportation resources are available.

The Washtenaw Health Initiative received a Special Recognition Award in May 2016 from Huron Valley Ambulance for the WHI's efforts to reduce the rising number of opioid overdoses and deaths in the county. The award, presented at HVA's annual EMS Recognition Awards dinner, recognizes an organization or group for outstanding work in the community.

The <u>Ann Arbor News highlighted</u> the WHI Washtenaw Opioid Project's life-saving efforts, which earned the WHI the HVA's Special Recognition Award.

Co-chairs of the Washtenaw Health Initiative, Bob Guenzel and Norman Herbert, co-chairs of the Opioid Project, Marci Scalera, and Stephen Strobbe, and Center for Healthcare Research & Transformation staff Theresa Dreyer, Heather Guenther, and Marianne Udow-Phillips were present to accept the award.

The WHI Opioid Project formed in 2013 to combat the rising number of opioid overdoses and deaths in Washtenaw County. The group - which brings together more than 100 organizations including health systems, treatment providers,

Anya Abramzon, Executive Director of Jewish Family Services, emphasizes that it is not just JFS that should prepare for this increase: the community can prepare as well. Organizations can expect higher demand from refugees seeking services and resources, including translation services (especially Arabic), affordable housing options, and transportation accessibility. One of the most important things that can be done to prepare is to educate the community. This education is especially important in schools, where bullying and teasing can be particularly harmful to children who resettle of their life-saving work! here after possibly experiencing the trauma of war or other violence. JFS is working with the cities of Ann Arbor and Ypsilanti, and the County government to develop a Welcoming Initiative, aimed at creating more welcoming, immigrant-friendly environments.

Ultimately, this coming year will require JFS to adapt to the new challenge set before them. It is also an opportunity for Washtenaw County-based organizations to open their arms and support JFS and the refugees who settle here. JFS offers resources to educate and build awareness for the community. public health, law enforcement, and the recovery community - uses a framework known as the Lazarus Model that targets opioid use and addiction from multiple perspectives. The project's work includes increasing provider education on prescribing practices, developing best-practice guidelines for providers, and training law enforcement officers to administer Naloxone, a drug that reverses opioid overdose effects and helps prevent deaths.

Washtenaw County Public Health releases 2015 **Annual Report**



This month, Washtenaw County Public Health (WCPH) released its 2015 Annual Report, highlighting its recent national accreditation and creation of the Washtenaw County Board of Health. In August 2015, Washtenaw County Public Health became the fourth health department in Michigan to receive national accreditation from the Public Health Accreditation Board, and one of only 79 in the nation to receive the honor.

The report also notes the Washtenaw County Board of Health selected its first-ever board in January 2015. The board oversees WCPH programs and services, and advises the Washtenaw County Board of Commissioners on health issues, health priorities, and potential solutions.

The report also includes WCPH's strategic goals for 2016-2018, which are:

- Ensure the Washtenaw County Dental Clinic reaches and serves low-income residents.
- Lead health improvements prioritized in the Washtenaw County Community Health Improvement Plan under perinatal health, access to care and vaccine-preventable diseases.
- · Focus on health equity.
- Be a strong voice for public health, secure resources to improve health for all and fully support staff in accomplishing excellent, efficient work.

WCPH also released quarterly <u>Opioid Reports</u> in 2015, summarizing information on opioid-related overdoses and deaths occurring among Washtenaw County residents.

SIM Update



The State of Michigan released more information on the State Innovation Model (SIM) since the last update in the WHI's March/April Newsletter.

Regionally, the WHI and CHRT are working with multiple organizations within the

designated Community Health Innovation Region (CHIR), which includes Washtenaw and Livingston counties, to prepare for SIM implementation in late 2016. The WHI created a SIM work group, chaired by Doug Strong and Paul Valenstein, which meets monthly. The SIM work group includes representatives from Livingston and Washtenaw counties, including both health departments, the local Community Mental Health service providers, health systems, and Medicaid health plans. The SIM work group has also recently developed three subcommittees:

- 1. Patient Centered Medical Home / Accountable System of Care
- 2. Data and Information Technology
- 3. Community-Clinical Linkages to Reduce Emergency Department Use

A more in-depth update on the SIM and the WHI's involvement will be provided at the July 25 WHI Stakeholders Group meeting. General information and webinars about the SIM, the CHIR and other information can be found on the state's SIM website. The WHI will continue to provide information as it becomes available.
