## Meet the SIM Community Health Workers!

## State Innovation Model (SIM) Updates



## Community Care Coordination

The Livingston-Washtenaw Community Health Innovation Region (LWCHIR) has moved into

the implementation phase of the State Innovation Model clinical-community linkage intervention. The intervention delivers enhanced care coordination to participants at twelve community sites called hublets, including both social service and clinical agencies. Nine of the 12 participating hublets have started piloting the intervention by enrolling individuals and the remaining three hublets will begin the process as soon as they have the necessary information sharing agreements in place. This pilot phase allows hublets to obtain consent to enroll participants who meet eligibility criteria and with whom they have already been working or already have a relationship. The pilot phase enables hublets to adapt the intervention and implement changes in their work load. A complete roll-out with participant referrals from non-hublet entities will begin after the pilot phase. Additionally, the hublets will attend quarterly quality improvement meetings to identify opportunities to improve intervention processes throughout the implementation phase.

### Social Determinants of Health Screenings at **LWCHIR Practices**

The three large provider organizations (POs) in the LWCHIR (Huron Valley Physicians Association, IHA, and Michigan Medicine) jointly designed a patient screening tool to screen patients for needs related to the social determinants of health, such as transportation, food security, and housing. Staff at each PO will connect patients to agencies and social service providers that will address patient needs beyond the clinical setting. This screening will be given to patients at well visits, once annually to each patient. The screening is already underway across Michigan Medicine and is rolling out in November at HVPA and IHA practices. The LWCHIR plans to aggregate this screening data to monitor reported social service needs at the community level.

## Changes to the Open Enrollment **Period for Marketplace Plans**

The federal government has made major changes to Affordable Care Act outreach, education, and enrollment activities. The 5th Open Enrollment Period (OE5) this fall will be the shortest ever, lasting just six weeks: from 11/1/17 to 12/15/17. Federal agencies have reduced funding for advertising and for local organizations that provide enrollment assistance.

As in previous years, the WHI Medicaid and Marketplace Outreach and Enrollment group is creating and distributing community-wide outreach flyers promoting OE5. The group has also secured funding from the Washtenaw Health Plan for local marketing and advertising efforts. Outreach will target students, small businesses, and immigrant communities; the group also plans to coordinate enrollment events at the University of Michigan, Washtenaw Community College, and potentially Eastern Michigan University.

The HealthcareCounts.org website, operated by the Washtenaw Health Plan, lists agencies where individuals can receive help enrolling in health care coverage.
