Multiple factors including opioid misuse, limited treatment resources/access and gaps in knowledge contribute to this problem. This summit will bring together addiction professionals, providers and the community to educate, increase awareness, destigmatize and cultivate community driven solutions to opioid misuse and overdose.



Afternoon Professional Development Session

Target audience

Addiction professionals, prescribers, and service providers who work with opioids and/or people who are currently using or have used opioids.

Learning objectives

Understand the current state of the opioid epidemic in Washtenaw County

- Participants will be able to describe past and current country trends in the opioid epidemic

Understand facts vs. myths about recovery

- Participants will be able to identify multiple paths to recovery
- Participants will be able to distinguish that recovery from SUD is multifaceted, with social, cultural and medical elements

Outline various treatment resources for substance use disorder in Washtenaw County

- Participants will be able to identify the scope of SUD services available in Washtenaw County and process for referrals to treatment
- Participants will be able to describe the role of payment and insurance coverage in locating appropriate treatment
- Participants will be able to use patient preference and individual psycho-social needs in determining the best SUD treatment

Understand communication tools and methods for working with SUD patients

- Participants will be able to articulate the basic principles of Motivational Interviewing and apply it to their practice
- Participants will be able to articulate Cognitive Behavioral Health tools and apply it to their practice
- Participants will be able to articulate the role of a Bio/Psycho/Social screening in treating patients and apply it to their practice

Review current state of legislation about opioid prescribing, understand the logistics of implementation

- Participants will be able to articulate the requirements and consequences of the recently passed legislation regarding opioid prescribing and apply it to their practice
- Participants will be able to incorporate new tools and standards into workflow and practice
- Participants will be able to apply the most recent regulatory actions regarding implementation of the new laws to their practice

Review the administration of naloxone for an opioid overdose

- Participants will be able to identify an opioid overdose and administer naloxone

- Participants will learn about recovery and the importance of community in treating substance use disorder.
- Participants will understand recovery from the perspective of an individual with lived experience.

Review the administration of naloxone for an opioid overdose

- Participants will be able to identify an opioid overdose and administer naloxone.
- Participants will know where to get naloxone.
