Key Summary Points

- Approval of past meeting notes:
 - October 30th Meeting notes:
 - Reviewed and approved.
- Project updates:
 - o UNITE:
 - New focus for 2020 is food insecurity. Prior to COVID, the focus was on social isolation which was identified from the 2019 Needs Assessment
 - Due to COVID-19, food access became more difficult:
 - Food distribution sites lost volunteers (primarily older adult) volunteers)
 - Ann Arbor Meals-On-Wheels + Ypsilanti Meals-On-Wheels:
 - Dropped down to 3 days of delivery a week to limit interactions with clients
 - Switched to alternating days to ensure that the same amount of food was being distributed
 - Additional Food Pantries launched
 - The UNITE group evaluated this new focus with some key questions in mind:
 - How UNITE could make an impact and what strategies to employ
 - How to really address food insecurity together with other organizations
 - How can current programs be expanded to assist with gaps?
 - Open Communications, emphasis on continued conversations and feedback from the community



 Communications with Washtenaw County Food Policy Council – to ensure there is no duplication of work

2021 Priorities:

- Reviewed the priorities for 2021 and discussed the context of how the priorities fit within the strategic plan areas developed at the end of 2019; an important component of the strategic plan is to include more community voices in the group's decisions and conversations and moving towards activities of advocacy.
- Strategic priorities include an intentional emphasis on racial equity, some strategies that are being developed include:
 - Exploring in depth the desired future state
 - Creating awareness; taking an advocacy role in the community
 - Amplifying local initiatives that promote health equity
 - Clearly communicate this work at the system's level and to the Stakeholders working on the ground
- *Action Item: Approve FY 2021 Budget:
 - Unanimously approved.
- **Steering Committee position transitions:**
 - o Norman Herbert-
 - Sharon Moore has volunteered to be the co-chair.
 - o Pastor George Waddles Jr. he has chosen not to renew his term
 - He has given his recommendation from the faith community
 - Other open positions could be filled by Community Ambassador, looking for nominations for this role
- WHI's role in communicating the safety and efficacy of future COVID vaccine: Steering Committee discussed WHI's role and received guidance from Jimena
 - WCHD is meeting with the health systems to coordinate vaccine efforts
 - It will be awhile before it is available to the public at large

 - Communication and community outreach will be important and a role for WHI
 - The health department is engaging in outreach to understand how to best reach communities with information about the vaccine and understand who and what the best messengers will be
 - Multifaceted effort to get vaccine acceptance, partnering/communication across sectors will be important
 - Utilize community networks to inform/expand messaging and outreach
 - Jimena gave a recommendation of the WHI assisting with community communications.
